ACKNOWLEDGEMENT OF RISK / WAIVER OF LIABILITY

To Participants and Parents

The Camp Staff and Outdoor Education contractors are trained and qualified to take prudent care of campers' safety and well-being, while **Adventure Unlimited** leaders will endeavour to apply their understanding of Christian Science to ensure the proper care and comfort of all campers in the program. However, some inherent risks from events including but not limited to unpredictable weather, equipment malfunction, animal behaviour, river and surf conditions, staff judgement, vehicular accidents and other risks relative to our activities cannot be fully controlled or eliminated.

We understand **Adventure Unlimited** and **YMCA Mount Evelyn** and its agents and employees do not accept liability for loss of property or damage or personal injury arising from the use of their facilities.

We accept that **YMCA Mount Evelyn**, their owners and employees, may provide equipment and basic instruction at the start of sessions, and will not accept any liability for any accident, damage or injury to the activity participants or any other person/property.

This **Waiver of Liability** confirms for each participant that:

1. We will partake or may partake in a specified list of activities during our visit; and
2. We accept that the listed activities carry an inherent risk and can result in Injury; and
3. We accept the risks involved and are responsible for our own actions and/or involvement; and
4. We are under no obligation to participate or complete the activities if we have concerns about our ability to do so; and If anything is unclear to us in the briefing then we will raise our concerns with a member of **Adventure Unlimited's** team who is conducting the briefing; and
5. To the best of our knowledge, we are physically and emotionally able to participate in the advertised activities and know of no reason as to why we should not.

This waiver does not extend to exclude liability resulting from **Adventure Unlimited's** negligence or include reference to damage to property.

For minors, a parent or guardian having full legal responsibility for decisions regarding their minors are required to sign the waiver.

As parents/guardians signing for minors in our care, we understand that it is our responsibility to ensure that we provide the necessary information to all participants or parents/guardians of any participants so that they are able to make an informed decision consenting to undertake the listed activities on the risk waiver.

Activities may include but are not limited to:

- Archery
- Crate stack challenge
- Flying Fox
- Games

- Giant Swing
- High/low ropes courses
- Hiking on or off site
- Native wildlife discovery
- Orienteering or Scavenger Hunt

We understand that our signatures on this document authorises **us and/or our child/ren or those in our care** to participate in all activities and trips at the **Adventure Unlimited** 2023 Easter Camp, both on and off the **YMCA Mount Evelyn** property, including using transport organised by **Adventure Unlimited**. In the event that our child/ren under 18 attend offsite activities that **require completion of further waiver forms, we authorise Adventure Unlimited leaders to complete those forms on our behalf.**

We, on behalf of our child/ren and myself, release and waive any claim of liability against **Adventure Unlimited** and its leaders, Christian Science practitioners or nurses, or Camp staff, or Outdoor Education instructors, with respect to any injury, illness or death occurring from camp activities. We agree to indemnify and hold harmless **Adventure Unlimited** leaders and supervising staff with respect to any claim asserted by or on behalf of our child/ren as a result of any such harm.
